Motion 20/XII of the Parliament of Catalonia on the 2030 Agenda for Sustainable Development

Proc. 302-00022/12

Plenary of the Parliament

In its session held on 9 November 2018, the Plenary of the Parliament, in accordance with article 161 of the Rules of Procedure, has debated the Motion following an Government's appeal regarding the 2030 Agenda for Sustainable Development (proc. 302-00022/12) presented by the Member of Parliament Ferran Civit Martí, from the Republican Parliamentary Group, and the amendments presented by the Ciutadans (Citizens) Parliamentary Group (reg. 20691), and the Junts per Catalunya (Together for Catalonia) Parliamentary Group (reg. 20702).

Finally, in accordance with the provisions of article 161 of the Regulations, it approved the following

Motion

1. The Parliament of Catalonia pledges to:

a) Integrate into its legislative action the 17 sustainable development goals (SDGs) and the 169 corresponding targets from the United Nations' 2030 Sustainable Development Agenda.

b) Create a working group within the Committee on Foreign Affairs, Institutional Relations and Transparency to study how the SDGs can be integrated and implemented in all parliamentary activities and to write a report on conclusions to be monitored.

c) Ensure the promotion of the 2030 Agenda in all the international and European associations and working groups to which it belongs.

2. The Parliament of Catalonia asks the Government to:

a) Prioritise the 2030 Agenda in the development of all its policies and continue with the work of developing a plan for the 2030 Agenda while ensuring the transversal integration, development and defence of the rights of women and sexual and gender diversity, with the corresponding timetable, and to present a written report to the Parliament during the second half of 2019 on the degree of fulfilment of the SDGs by means of the public policies of the Catalan Government (health, education and territory and environment, among others).

b) Develop a baseline document of a national agreement for the 2030 Agenda in Catalonia within three months and work on an interdepartmental plan that involves all the regional ministries with strategic lines for the attainment of each of the seventeen SDGs.

- c) Promote an alliance of public and private actors which, after having adhered to the national agreement for the 2030 Agenda in Catalonia, contribute to bringing the SDGs to Catalonia through specific commitments.
- d) Have the Sustainable Development Advisory Council appear twice yearly in the Parliament to explain the attainment of the SDGs for the 2030 Agenda.
- e) Ensure that in periodic appearances by each of the regional ministers in each of the committees related to the SDGs (Institutional Affairs Committee; Economy and Finance Committee; Committee on Foreign Affairs, Institutional Relations and Transparency; Education Committee; Territory Committee; Environment and Sustainability Committee; Health Committee; Justice Committee; Knowledge and Enterprises Committee; and Employment, Social Affairs and Families Committee) stock is taken of the degree of attainment of the objectives that are relevant to them.
